- Confirmation of load-shedding mitigation control in place on each site link.
- Evident coverage on each site

4. Terms and Conditions of RFQ

The terms and conditions are as follows: -

- The contractor is expected to do all the works according to set standards.
- Provide suitable tools, equipment and personnel for the execution of all the works.
- The appointed contractor must provide own transportation.
- The contractor must leave the site clean.
- Inspection will be done in all work done regularly.

5. Occupational Health & Safety

The Service Provider shall comply with all legal safety requirements as detailed in the OHS Act. The Service provider will his/her own safety PPE suitable for the proposed work.

Service provider and staff will be required to arrange necessary toolbox talks to a minimum of 3, project commencing, status sites visit and project completion and keep the records of the minutes.

6. Contract Duration

This is a 24-month period fixed rate contract term.

7. Induction Training

Silulumanzi will conduct an induction training on commencement of the contract to familiarize the Service provider with Silulumanzi environment and to create awareness of the do's and don'ts of the Company.
