1. Purpose & Objective

The purpose of the project is for sourcing of the most suitable, competent Water Tanker Trucks service provider in Nsikazi North & South (ZONE B Area).

Reputable local-based services providers are invited to submit the competitive prices.

The brief scope/sites of work are as follows:

4 X Tankers should be available to Silulumanzi on 24/7 standby basis - Nsikazi North & South:

2 x 5000 Litres

2 x 10 000 Litres

2 x 18 000 Litres

2. Terms of Reference

The terms of reference are as follows: -

Water Tankers should be based from **ZONE** B area **ONLY**.

Tankers to be disinfected and tested on appointment.

Tankers to be tested by Silulumanzi twice in a Week.

Tankers must be onsite 1 hour after the call logged.

Service provider shall provide the competent Driver and Diesel

3. Elimination Criteria

Vendors are advised not to commit fraudulent activities or forge documents. All abusers of the Procurement system, including forging or faking of returnable documents will be DISQUALIFIED immediately, and may be reported to SAPS and restricted from doing business with Silulumanzi.

Vendors will be eliminated under the following conditions:

- 3.1 Late Submissions of Quotes.
- 3.2 Submission at wrong location or incorrect email address (ONLY submit electronically).

4. Reporting & Administration

The service provider shall report to the site Foreman/Supervisor Silulumanzi Workshops.

5. Contract Duration

The duration of the contract is 12 months fixed rates basis.

6. Induction Training

Silulumanzi will conduct an induction training on commencement of the contract to familiarize the Service provider with Silulumanzi environment and to create awareness of the **dos and don'ts** of the Company.

7. Pricing Instructions

- Agreed Rates will be fixed for the 12 months contract duration.
- Prices needs to be provided in South African Rands (excl. VAT)
- Quotation should be on a company letter head, with validity dates and Terms and Conditions.
- Payments will be according to Silulumanzi payment Terms and Conditions.

8. Evaluation Criteria

- 8.1 Selection will be based on the **80/20 preference point system.**
- 8.2 Provide a valid B-BBEE Certificate or Sworn Affidavit indicating the B-BBEE Status level.
- 8.3 Valid SARS Tax Pin Certificate.
- 8.4 Valid Letter of Good Standing from Department of Labour.
